Executive Meeting.

Mrs. Smith, Mrs. Starkweather,

and your secretary attended a meeting  
of the school board for the purpose of  
discussing the purchase of a stove and  
a water heating appliance.

Mrs. Clayton and Mrs. Carlton  
examined several different stoves at  
various concerns as well as one at the  
home of Mrs. Carstens on River road.  
The stove at Mrs. Carstens' could be  
had for \$15.00. It was stated that  
the stove was in good condition and  
of sufficient size to take care of the  
cafeteria needs for some time to come.  
A P.E.P. man had stated the stove was  
in good working order.

The school board author-  
ized the P.T.A. to examine this stove  
and if found to be all right to purchase  
it and it would be paid for by the school.

The school board also advised they would make provision for hot water as soon as they knew what could be done financially.

Mrs. Smith asked Mr. Oatfield's advice with regard to having our first meeting jointly with dedication exercises and open house. Mr. Oatfield left it entirely up to the P.T.A. to handle this as they see fit.

A committee was selected, consisting of Mr. Schindler, Mr. McCain and Mrs. Starkweather.

Program to be put on as soon as Mr. Oatfield advises everything in the building is ready.

Mrs. Smith also brought up the subject of safety for the children crossing the highway. She had been advised by the highway commission that as far as they knew a school boy patrol was the only solution.

Oct. 23, 1936

First meeting

A business meeting of the Concord P.G.A. was held Oct. 23, 1936, at 2:30 P.M. in Concord School.

The meeting was called to order by Mrs. Smith.

The minutes of the May, 1936, meeting were read and approved.

The treasurer's report was read showing a balance of \$45.06 on hand.

Discussion was invited as to who should be hired as cook for the cafeteria.

Mrs. Worthington desired the position and had previously stated her charge would be \$2.00 a day.

Some discussion followed as to the ability of the P.G.A. to pay this amount and it was felt that Mrs. Worthington would be highly efficient and would conduct the cafeteria in such a way that these wages would be possible.

Mrs. Humphrey made a motion, "to employ Mrs. Worthington as cook for the year, at \$2.00 a day and if there is a deficit, to make it up by raising the money thru card parties."

The motion carried.

Mr. Schindler suggested that if good nourishing food was served in larger portions the patronage of the cafeteria would be increased.

Mr. Schindler made a motion, "that a committee of 3 be appointed, by Mrs. Smith to act as lunch room committee".

The motion carried.

A communication was read regarding the formation of a study group in this district. It was felt that such a group could not be started at this time, but Mrs. Humphrey suggested that 10 or 15 minutes of our P.T.A. program be devoted to telling the high lights of these lectures by those attending them. This suggestion was approved.

Another communication was read regarding a McCall magazine subscription offer which would entitle Concord P.T.A. to 50¢ from every \$1.00 subscription taken.

Mrs. Humphrey made a motion "that the question of card parties be referred to the finance committee."

The motion carried.

The question arose regarding the continuance of the \$1.00 prize to the room having the most mothers present, at each meeting.

Mrs. Coutress made a motion, "to continue the \$1.00 prize to the room having the most mothers present."

The motion carried.

A suggestion was made that the teachers talk to the pupils and urge them to exert all efforts to get their mothers to attend P.G.A. meetings.

The necessity for the installation of hot water was discussed and Mrs. Smith advised this matter was to come up at the next school board

2nd Meeting

Concord P.G.A. met at the school on Nov. 13th at 2:30 P.M. with Mrs. Smith presiding.

Minutes of the October meeting were read and approved.

The Treasurer's report was read in detail and showed a balance of \$51.73 on hand. Statement on file.

The membership committee reported 23 paid members to date.

The question of the father's membership dues being held for the use of the local organization arose.

Discussion as to the advisability of such a proceeding was carried on and Mrs. Gheissen made a motion, "that the fathers be termed associate members and their names withheld from the state organization."

Motion carried.

Mrs. Smith told of the purchase of posture charts by Mr. Schindler in line to the discussion which took place

at the last meeting.

Mr. Schindler expressed his willingness to stand this expense if this organization did not care to do so. In view of Mrs. Clayton's desire for these charts in her health work, Mrs. Atwood made a motion, "that we reimburse Mr. Schindler."

Motion carried.

Mrs. Smith spoke again of the need of the school for a sewing machine.

Mrs. Haynes has her name in with the Singer machine people to get a machine for less than \$10.00.

Motion made by Mrs. Steele, "that we buy a sewing machine as cheaply as we can."

Motion carried.

Mrs. Smith named Mrs. Carlton and Mrs. McNutt to take care of this purchase.

The McCall magazine self-help offer was again explained to those present and materials given to those desiring to help with this work. All

subscriptions to be turned over to Mrs. Smith.

Mrs. Thiessen spoke of the super-highway conditions and mentioned that a captain from Portland had spoken to the children at Milwaukee with regard to precautions to be used by them to avoid accidents. This captain has a highly trained police dog which entertains the children, thereby making his talk more interesting. Mrs. Thiessen advised she could get the captain to come to our school and talk to the children. This was thought to be an excellent idea and would be planned for. There is no charge for this service.

The safety angle of crossing the super-highway arose and it was decided to take this up with the school board and see what can be done.

Mrs. Atwood made a motion, "that we call a special meeting with the school board and settle this problem".

Motion carried.

Fathers to be asked to attend.

Mrs. Smith spoke of some of the members desiring to put on an old fashioned dance as a means of raising funds. This was considered a good plan.

Continuance of card parties as held in previous years was discussed

Mrs. Atwood made a motion "that this association go on record as favoring the card parties."

Motion carried.

Mr. Kelton of the 4-H Club spoke of 4-H Club work in this school and of making an attempt to get classes started in cooking and sewing.

Mr. Kelton stated that to get such work under way it would be necessary to have leaders who could devote time to this as nothing could be done without good leaders. Mr. Kelton asked for cooperation in this matter.

A vote of the rooms was taken, the fifth grade winning.

Mrs. Smith told of an executive meeting at which a budget for the year was planned.

It was stated that the cafeteria would open Monday, Dec. 6th.
